Appeal Process:

Players whose names appear on this list who believe that they should not be included have the right to appeal to have their name removed. In order to appeal, the player must submit a formal request via email or in writing to Brad Thomson at osasbradthomson@gmail.com or 18 Sugar Maple Street, Kitchener, ON N2N 1X5.

The request must include supporting information that explains why you believe that you should be eligible to pitch in the OASA Intermediate Mens B category for the current year.

Teams may only have 1 player who has successfully appealed to have their name removed from this years Ineligible Pitchers List.

All appeals will be acknowledged and ruled on by a committee of individuals chosen by the OASA executive within two weeks of the receipt of the request.

The deadline for appeals to be submitted for the current year is June 1.
